## Southeast Management School Scholarship Opportunities

The Louisiana Credit Union League in partnership with the Southeastern Regional Credit Union School (SRCUS) invites interested applicants to apply for scholarships to attend the **2024 Southeast Management School** hosted by SRCUS June 16 - 21 at the University of Georgia in Athens, Georgia. The joint scholarship program provides \$3,000 in scholarships per state, to be awarded to students based on future management potential, involvement in the credit union movement, positions held, and other supportive criteria. The scholarship program is open to all professionals from League-affiliated credit unions.

To apply for scholarships, prospective students must complete the following application, include a copy of the credit union's year-end financial statement, and return both to the LCUL by April 12th. Additionally, scholarship applicants are encouraged to proceed with registering for this year's program via [www.srcus.org](http://www.srcus.org) to ensure their spot in the class. Those awarded a scholarship will have their registration fees reimbursed.

LCUL will notify all scholarship recipients by April 19<sup>th</sup>.
